ORDER UNDER SECTION 10 A

By virtue of the powers vested in me under Section 10 A of the Customs Ordinance (Chapter 235) as amended by Act, No Act No.83 of 1988, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this order levy on imported goods specified in Column I of the Schedule hereto, a surcharge at the rate specified in the corresponding entry in Column II on Customs Duty, both General and Preferential, from June 01, 2022 for a period of 06 months.
